Here by agrees as follows:

1. Moon Valley will provide guided hunting services to the Hunter during the hunt for which among the following alternatives the hunter is successful, in the unit for which the hunter is drawn: 1st choice, Unit ____ Dates: _____ - _____, 2nd choice Unit _____ dates: _____ - _____ 3rd choice Unit _____ dates: _____ - _____, in connection with the pursuit of _____ (game animal) in the state of _____.

2. The Hunter understand that the process of assignment of hunting unit is based on public drawing and is not under the control of Moon Valley. The Hunter authorizes and requests the Moon Valley make all applications and file all documents necessary to ensure timely participation in which draw, and by these presents constitutes Moon Valley his attorney in fact, for such purposes to so act in his name, place, and stead.

3. The price of the hunt is \$ _____, to be paid as follows:

* A non-refundable deposit of \$1000 upon notification of success in any of the 3 draws as set forth above;

* The remainder will be remitted no later than one day before the commencement of the hunt;

* At the time of execution hereof, the hunter will provide a check or credit card for all licenses, stamps, and draw fees, payable to the appropriate agency of the state where the hunt is to take place. Moon Valley shall submit the same with required application in the mane of the Hunter.

Note: Payment shall be made in cash or certified funds unless otherwise agreed by the parties; provided however that personal checks will be accepted if payment is made not later than 30 days prior to the commencement of the hunt.

4. Moon Valley will provide the following services: Food, Lodging, and Qualified Guides to accompany the Hunter during the legal hunting hours. This hunt is a ____ one guide per hunter hunt or a ____ one guide per two hunters hunt. **(check one).**

5. Food and Lodging provided will be consistent with the object of the contract : the hunting and legal harvesting of wild game in pristine natural surroundings will consist of comfortable cabins, self-contained camp trailers, or in the case of wilderness excursions, wall tents. Home-cooked meals will be healthy and nutritious. No other amenities will be provided, except at the special request of the hunter upon a 30 day prior notice, at extra cost.

6. Moon Valley does not guarantee the hunter will be successful in harvesting the game pursued, but will undertake all reasonable efforts to that end to ensure an enjoyable, safe, unique experience.

7. Alcoholic beverages are allowed in moderation in camp only after legal hunting hours. If hunter engages in boisterous, disorderly, or unseemly conduct such as to disturb the peace and quiet of the camp or endanger the safety of others, Moon Valley may cancel this contract, retain all sums paid by the hunter, and expel hunter forthwith from the camp. Illegally possessed controlled substances are prohibited and likewise shall cause cancellation of the hunt and retention of cost paid.

8. The Hunter acknowledges that hunting is an inherently dangerous activity and specifically assumes all risk attendant thereto. Moreover, he/she agrees to indemnify and hold Moon Valley harmless from any and all acts that he/she may commit in the course of the hunt whether negligent, willful, or otherwise.

9. This is the entire agreement between the parties and may only be amended, modified, or superseded by a subsequent written agreement signed by the parties. This agreement and any action arising hereunder shall be construed under the laws of the State of New Mexico. Any cause of action or controversy shall be tried or adjudicated in New Mexico.
